
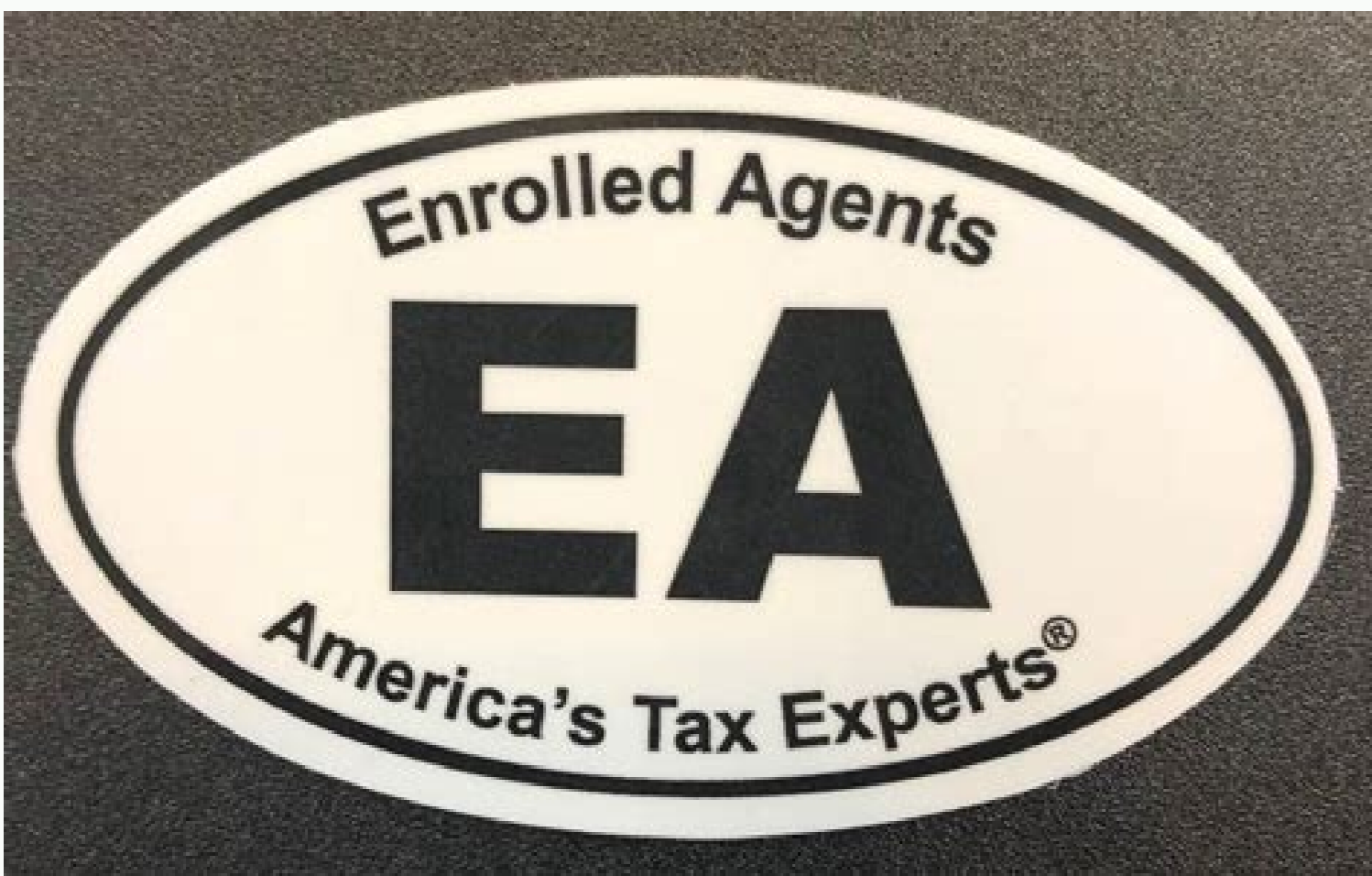

The IRS weights the 85 scored questions equally. For this reason, most EA candidates start with this part. If you don't file by your filing date, you may have to pay penalties and fees. You should also learn about EA exam scoring. After all, in order to become an enrolled agent (EA), you must pass the Enrolled Agent exam (officially known as the Special Enrollment Exam or SEE). What's more, the syllabus changes from time to time. To start, you can download a limited number of practice questions from the IRS.
